- Parents will be involved and notified by meeting flyers and notices in specific languages necessary.
- Parents will be invited to all "family fun" nights, literacy nights, Back to School, Open House, and other performances throughout the year.
- Parents will have access to the school's website and community email messages.

The school convenes an annual meeting to inform parents about Title I, Part A requirements and about the right of parents to be involved in the Title I, Part A program (ESSA Section 1116[c][1]).

- Springbrook will offer meetings to be informed about Title 1 information.
- Parents will be emailed important information regarding Title 1 requirements.
- Springbrook's website will be kept current with pertinent and up to date Title 1 information.

The school offers a flexible number of meetings for Title I, Part A parents, such as meetings in the morning or evening (ESSA Section 1116[c][2][3][4}B).

- · Springbrook will offer virtual zoom meetings one in the morning and one in the evening
- Springbrook is planning to offer four EL meetings this year at times and in ways parents can
- easily access (ie. Both morning and afternoon, in-person and "zoom" format)
- Parents will be invited to PTA meetings, Title 1 meetings and parenting seminars (TBD).

• Parents will be invited to participate and ask questions regarding the Title 1 program, including curriculum and assessment.

The school provides parents of Title I, Part A students with timely information about Title I, Part A programs (ESSA Section 1116[c)(4][A]). How does the school provide the information?

- Parents will receive emails regarding Title 1 program.
- Parents will receive dedicated flyers that will be sent home regarding Title 1 program.
- Parents will have access to the school's website with the most current and up to date information.
- Parent Teacher conferences with options of in person or via zoom and with translators, as needed

If requested by parents of Title I, Part A students, the school provides opportunities for regular meetings that allow the parents to participate in decisions relating to the education of their children (ESSA Section 1116[c][4][C]). How does the school provide the opportunities?

- Parents will be invited to attend regularly scheduled PTA meetings.
- Parents will be invited to attend all family engagement nights (in person or virtual) with their children.

The school engages Title I, Part A parents in meaningful interactions with the school. To help reach these goals, the school has established for parents to volunteer in the classroom, attend EL and Title 1 meetings, and attend Back to School night and open house.
