# **PUBLIC INFORMATION MEETING**

## Dear Current Resident:

Measure E was passed by Irvine voters in June 2016 to ensure all Irvine Unified School District students; not just those in newer neighborhoods, have access to modern learning environments and technology to support IUSD's high academic standards and to prepare students for 21st century college and career opportunities. Measure E will provide a maximum available bond issuance of \$319 million for facilities improvements at 28 of the District's aging schools.

In Series 1 of the Measure E Improvements, the District has identified Springbrook Elementary School for an extensive modernization and new music classroom building. The work for these projects are scheduled to begin June 2019 and continue through August 2020.

Due to the intensity of this work, it is necessary to relocate the school temporarily at the El Camino Real School site for the 2019-2020 school year. El Camino Real School site has been upgraded and additional relocatable classroom buildings have been placed to accommodate Springbrook Elementary School.

All interested persons are invited to attend a public information meeting, which will provide information on the work proposed for Springbrook Elementary School. IUSD representatives will be available to answer questions. This meeting will begin promptly at 6:00 p.m. on Thursday, November 29, 2018.
